Graduate Nurse Program Requirements

Each of the GNP requirements listed below must be met for successful completion of the Graduate Nurse Program:

- Mandatory attendance x4 Graduate Nurse study days
- Completion of core clinical practice standards and self-directed learning packages submitted >4
 weeks prior to GNP end date
- Attend monthly meetings with NUM as scheduled
- · Successfully meet the probationary review
- Complete all allocated rotations within assigned timeframes including weekly learning goals & objectives each week
- Completion of annual performance review and development planning tool (PRDPT). Performance
 reviews must be completed and submitted within required timeframes and indicate the required
 standard is met.
- Meet all MBPH personal leave requirements and specific Graduate Nurse Program leave requirements.

Graduate Midwife Program requirements

Each of the GMP requirements listed below must be met for successful completion of the Graduate Midwife Program:

- Attend x2 weeks SN in Birth Suite with Education team and complete the learning goals and objectives
- Attend x2 weeks SN in SCN and complete the learning goals and objectives
- Attend x4 mandatory Graduate Midwife study days
- Complete self-directed learning packages
- Complete core clinical standards
- Complete annual Performance Review with the Maternity Education team
- Complete the Maternity clinical skills list
- Attend Monthly meetings with NUM/Educators
- Meet all MBPH personal leave requirements and specific Graduate Midwife Program leave requirements.
